

Trigon Russia Top Picks Fund
Fact Sheet | March 2019
Overview

Trigon Russia Top Picks Fund invests into securities traded on the global regulated markets with a Russian market focus. The Fund's portfolio consists of approximately 25 different securities that are deemed as most attractively valued by our investment team.

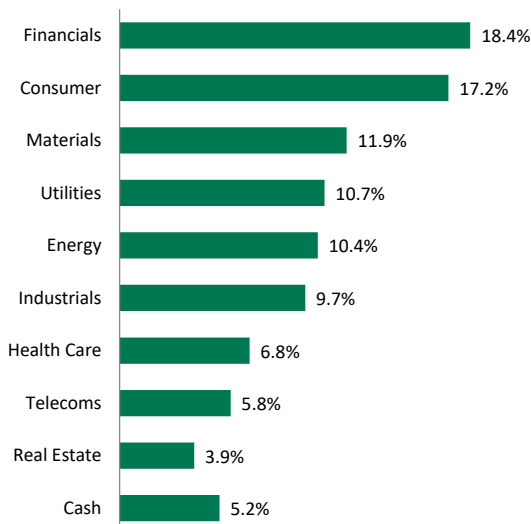
When making our investments, we seek a beneficial risk-return relationship, taking into account fundamental indicators as well as opportunities based on technical analysis and the inefficiencies of the region's stock markets.

Fund Manager's Comments

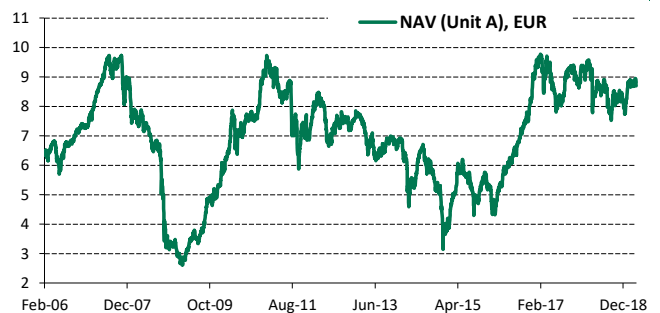
Global markets were positive in March on monetary policy easing amid slowing global growth. MSCI World TR Index rose +2.8%, outperformed MSCI EM TR and MSCI Russia TR +2.3% returns. The Russian market was volatile on the renewed sanctions talk, but finished the month higher on oil price recovery. Trigon Russia Top Picks Fund returned -0.1% due to mid-cap positions' underperformance.

Brent oil prices were up another +4.4% to over 70 USD/bbl and are now up by 30.5% YTD. Russian ruble appreciated +2.3% against euro, as the economic data continued to improve and endless warnings of new sanctions made investors immune to the noise. The new Mueller report, that after two years of investigation found no evidence of collusion between Russian and US president Trump, has also added some optimism. Central Bank of Russia has kept the key rate unchanged at 7.75%, although inflation expectations were cut on lower effect from the VAT increase. Earnings season has ended in March for majority of our portfolio companies. We are pleased with their results, especially with dividend payouts, which are the highest in the history.

Looking forward, Russian market looks particularly compelling given its underperformance, value, and the current oil price level. Russian stocks retain one of the highest dividend yields and lowest P/E ratios of any major emerging market. Russian companies have substantially increased their dividend payouts over time from 15% to current 45-50%. MSCI Russia's estimated P/E ratio for 2019 is now 6.0x and dividend yield of 6.9%. Trigon Russia Top Picks Fund portfolio is trading at a weighted average of 5.7x expected earnings for 2019 and 9.6% dividend yield.
